

Refund Policy

We do not give refunds unless we fail to deliver the goods as agreed. In such cases, please contact us at webshop@btg-btl.com.

Late or missing refunds

If you haven't received a refund yet, first check your bank account again. Then contact your credit card company, it may take some time before your refund is officially posted. Next contact your bank. There is often some processing time before a refund is posted. If you've done all of this and you still have not received your refund yet, please contact us at webshop@btg-btl.com.

Returns and Exchanges

We do not accept returns unless exceptional circumstances apply, in such cases we will provide you with a reference code. Returns without a reference code will not be accepted. We only allow returns in special circumstances, this means your item must be unused and in the same condition that you received it. It must also be in the original packaging. We only replace items if they are damaged or lost during shipping. Shipping
